

# Radicava (edaravone)

(Intravenous)

## I. Length of Authorization

Coverage will be provided for 6 months and may be renewed.

### II. Dosing Limits

#### A. Quantity Limit (max daily dose) [NDC Unit]:

• Radicava 60 mg/100 mL single-dose bag: 1 bag per day for 14 days of a 28 day cycle initially, followed by 1 bag per day for 10 days of a 28 day cycle

#### B. Max Units (per dose and over time) [HCPCS Unit]:

- Initial dose: 60 billable units daily for 14 days, followed by 14 days off per 28-day cycle
- Subsequent doses: 60 billable units daily for 10 days out of 14 days, followed by 14 days off per 28-day cycle

### III. Initial Approval Criteria<sup>1</sup>

Site of care specialty infusion program requirements are met (refer to Moda Site of Care Policy).

Coverage is provided in the following conditions:

• Patient is at least 18 years of age; AND

## Amyotrophic lateral sclerosis (ALS) $\dagger \Phi$ <sup>1,2,7,8</sup>

- Patient has a diagnosis of clinically definite or probable ALS based on El Escorial revised criteria or Awaji criteria; **AND**
- Patient has a disease duration of 2 years or less; AND
- Patient has a percent-predicted forced vital capacity (%FVC)  $\ge$  80%; **AND**
- Baseline documentation of retained functionality for most activities of daily living [i.e., score of 2 points or better on each individual item of the ALS Functional Rating Scale Revised (ALSFRS-R)]

### IV. Renewal Criteria <sup>1,3</sup>

• Patient continues to meet the indication-specific relevant criteria identified in section III; AND

- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include the following: hypersensitivity reactions, sulfite allergic reactions, etc.; **AND**
- Patient has responded to therapy compared to pretreatment baseline with disease stability or mild progression indicating a slowing of decline on the ALSFRS-R (patient has not experienced rapid disease progression while on therapy); **AND**
- Patient does not have a cumulative score on the ALSFRS-R of  $\leq 3$

## V. Dosage/Administration<sup>1</sup>

Indication	Dose		
ALS	<ul> <li>60 mg (one 60 mg infusion bag) administered as an intravenous infusion over 60 minutes</li> <li>Initial treatment cycle: daily dosing for 14 days followed by a 14-day drug-free period</li> <li>Subsequent treatment cycles: daily dosing for 10 days out of 14-day periods, followed by 14-day drug-free periods</li> </ul>		

Do not use if the oxygen indicator has turned blue or purple before opening the package. Once the overwrap package is opened, use within 24 hours.
